2016 Cycle - Share with EPA

Cycle Selection -

This page allows Organization Assessment Administrators to choose whether to share the Draft or Working Copy (In-Progress version) of the currently selected Assessment Cycle with EPA. Sharing the cycle allows EPA to see the current status in ATTAINS, including Assessment changes made since the previous Snapshot.

Assessment Administrators can choose to 1) Not Share a cycle, or 2) Share a cycle as View (Read Only), or 3) Share a cycle that is viewable and Editable by EPA. The decision applies to the entire cycle. The default setting is "Not Shared". The settings below apply to the currently selected cycle. The settings will reset to "Not Shared" for the next cycle.

If "Not Shared" is selected, then EPA will not see the Draft Assessment cycle. Once the cycle is promoted beyond Draft, then EPA will see the contents of the Snapshot (which are public), but will not see any changes made since the Snapshot was taken.

If Shared as "View (Read-Only)" is selected, then EPA will see the Draft Assessment cycle and any changes made since the latest Snapshot was taken. However, EPA will not be able to edit anything in the Assessment cycle until it is promoted to an EPA-controlled status such as EPA Document Decisions.

If Shared as "Editable by EPA" is selected, then EPA users with Assessment Reviewer permissions for the Organization will be able to see the Draft Assessment cycle and make edits. This may be useful if the Organization has requested assistance. Editing capability only applies at the Draft Assessment cycle status. Once the cycle is promoted beyond Draft status, ATTAINS will change the value of sharing for each shared Assessment Unit to "View (Read-Only)". At that point, EPA users will be able to see the current status of any Assessment in the Organization's Working Copy (In-Progress version), but cannot make edits until the cycle is promoted to an EPA-controlled status such as EPA Document Decisions. Any EPA users with Assessment Read-Only permissions for the Organization will be able to view but not edit, even while the cycle is in Draft status.

These settings may be changed at any time during the Assessment cycle.
